## Attachment 2: Childcare

**The childcare hours are from Friday to Saturday from 9:00 a.m. to 12:00 p.m. and from 1:00 p.m. to 5:00 p.m.**

The offer of childcare during the conference of the European Chromosome 11 Network e.V. is voluntary. The people looking after the children act according to their best knowledge and faith. However, we expressly point out that the service is not a professional childcare programme.

Making use of this childcare offer is at your own risk. The people looking after the children as well as the European Chromosome 11 Network e.V. do not provide any insurance cover. Any liability of the people looking after the children and the European Chromosome 11 Network e.V. for personal injury and property damages is excluded. By making use of the childcare offer, this liability exclusion is accepted.

Should it not be possible to care for the child appropriately by the people looking after the children (e.g. the child refuses supervision by other people), it is at the discretion of the people looking after the children to return the child to the persons having custody of the child.

The medical and care attention (e.g. changing diapers) given to the children will continue to be ensured by the person having custody.

The persons having custody undertake to pick up the child from the people looking after the children on time before the end of the childcare hours. If it is intended that a third party pick up the child, this must be notified on time.

The persons having custody of the child undertake to provide all information relevant for childcare.

A box will be made available for each child at the start of the childcare, in which outdoor shoes, jacket, smaller equipment (e.g. glasses or hearing aids), favourite stuffed animal or similar can be stowed away. Wherever possible, a nametag should be applied on these objects.
